A. Call to Order via ZOOM: The regular monthly Board Meeting of the Otter Rock Water District Board was held on December 14, 2021 via ZOOM. The meeting convened at 6:05 pm with Commissioner Hall presiding.

C) Consent Agenda:

Missing summaries for eight previous meetings to complete the fiscal year under audit plus the summary for the November meeting were submitted by Commissioner Elliker. Board review of the meeting summaries resulted with no changes needed and were approved.

D) Reports, updates and announcements

- a. Water Operator's Report Robert Trotter of Hiland Water presented a report on current water conditions. November water tests resulted in no positives of any contaminants. Hiland has a new staff member for the Newport area who was introduced to our system..
 - 1. Chlorination project update Hiland has added a pulse meter which has resulted in continuous residual readings of 0.2 ppm. They also found there was a problem with the sonic meter and are waiting for replacement from the manufacturer. They will wait to send the letter to the state until we have some history of the functioning system.
 - 2. Meter installations update no update.

b. Office/Treasurer's Report

Commissioner Cutler presented a report of current finances and answered questions. See the website for the written Treasurer's report and the current Profit & Loss Budget vs. Actual report. There was a discussion on delinquent accounts

There was a discussion on the breakout and approval of the latest Hiland bill.

The results of the Compilation Report by Grimstad will be sent out to the board.

Commissioner Hall commented that the board vote on upholding our resolutions did not happen. Commissioner Cutler commented that because the Treasurer's Report was sent so late they didn't expect the board to accept the report as it is. No motion was made to approve the report. A motion was made by Commissioner Elliker, second by Commissioner Taylor to approve payment of the current bills.
