a. Water Operator's Report – Curtis apologized for missing the last meeting due to an emergency repair at another system. The monthly written report has not been done yet and he has no information on spring flows. Chlorine residuals look good. (The board had some questions on the November invoice and had sent Curtis an email.) Curtis reported that since receiving the email from a board member, he had stopped all projects until it could all be discussed. Commissioner Elliker explained the district's need for invoice details on projects due to our funds, some of which are restricted, and our budgeted categories so we can accurately assign expenses to the proper accounting codes. Commissioner Goldhammer had some questions about the work on the vault installations at the tank farm and requested to meet Curtis on site to discuss the plan. Commissioner Goldhammer confirmed that Curtis would be ordering the boxes needed for additional meter installs.

b. Office/Treasurer's Report

The Treasurer's report was presented by Commissioner Goldhammer. See the website for the written Treasurer's report. We have not yet received the bill from Hiland for the month of December.
