A. Call to Order via ZOOM: The regular monthly Board Meeting of the Otter Rock Water District Board was held on April 12, 2022 via ZOOM. The meeting convened at 6:04 pm with Commissioner Hall presiding.

  - a. Water Operator's Report none as Hiland was not present for meeting.

#### b. Office/Treasurer's Report

Commissioner Cutler presented a report of current finances and answered questions. See the website for the written Treasurer's report and the current Profit & Loss Budget vs. Actual report. A motion was made by Commissioner Elliker, second by Commissioner Hall to approve the Treasurer's Report.

Bills ready for approval: A motion was made by Commissioner Elliker, second by Commissioner Hall to pay all the bills except the Hiland bill.

Commissioner Elliker reported that a commercial customer had a large leak in December and has not been billed for the water use over their base and asked if the board wanted to consider leak forgiveness. The customer's normal December usage never goes over their base and if we were to bill according to our rate table, their water use bill would be over \$735 in addition to their \$550 base charge. The board reached consensus on granting leak forgiveness.

#### c. Other correspondence -

The office received a request from Community Services Consortium (CSC) to participate in the Low Income Household Water Assistance Program (LIHWA) which provides assistance to pay water bills for qualified applicants.

A motion was made by Commissioner Elliker, second by Commissioner Cutler to sign the agreement with CSC to participate in the LIHWA program.

The office received a request for voluntary membership dues from Lincoln County Utility

Coordinating Council – Dig Safely. Their intent is to encourage and coordinate utilities projects for underground installations. The board reached consensus the district was not interested at this time.

  - b. **Columbia Bank accounts/signature cards** Commissioner Elliker will contact the bank to make arrangements for completing new cards.
  - c. **Hiland communications** There has been a problem with communications. By board consensus Commissioner Cutler will be the main contact with Hiland.
  - d. **Second street easement work** Commissioner Cutler has worked on possible solutions and communicating with affected parties. Lines need to be lowered to protect from continuous traffic, it may be wise to move some meters. Discussed hiring an outside contractor to do the work and get an estimate from Hiland.
  - e. **Workers' Comp Insurance form** renewal coming up, discussed coverage needed for upcoming year. Commissioner Elliker will work with Whitney to complete the renewal form.
  - f. **Community Center yard** Work is needed. Yard has been maintained by volunteers. Commissioner Elliker will send out an email asking for volunteers.
